# CERTIFICATION OF ELECTION RESULTS AND OF EXCLUSIVE REPRESENTATIVE

Before Chairman Drake, Vice Chairman Gillmor, and Board Member Verich: November 6, 2003.

Pursuant to Ohio Revised Code § 4117.07(C), the Board conducted a secret ballot election on October 21, 2003, for certain professional and nonprofessional employees of the City of Cincinnati. Pursuant to Ohio Revised Code § 4117.06(D)(1), employees voted to determine whether a majority of professional employees and a majority of nonprofessional employees wish to be included in a single unit for collective bargaining.

The Board certifies that the results of the unit-determination election are: professional employees cast seventy-seven (77) ballots, sixty-five (65) votes were for inclusion with nonprofessional employees in a single unit, and twelve (12) votes were for noninclusion with nonprofessional employees in a single unit. There were zero (0) challenged votes.

Nonprofessional employees cast five hundred thirty-eight (538) ballots, four hundred forty-four (444) votes were for inclusion with professional employees in a single unit, seventy-seven (77) votes were for noninclusion with professional employees in a single unit. There were seventeen (17) challenged votes.

Accordingly, the appropriate combined unit of professional and nonprofessional employees is as it appears on the attached (3) pages.

In the combined unit, the Board certifies that the results of the representation election are: six hundred eighteen (618) ballots were cast, five hundred seven (507) votes were for the Cincinnati Organized & Dedicated Employees (CODE), and ninety-four (94) votes were for No Representative. There were seventeen (17) challenged votes.

The Cincinnati Organized Dedicated Employees (CODE) has received a majority of the votes cast and is certified as the exclusive representative of all employees in the combined unit.
